subject before the conclusion of a contract, the processing is performed based on art. 6.1 lit b.) of the GDPR. The purpose of the processing of personal data on the She is MOM website is:

The notifications transmitted contain the so-called "tracking pixels," which inform us if the respective notification was opened, respectively, the date of its access. We may transmit personal information to public authorities or institutions following legal provisions or in good faith if:

Third-party may be empowered for hosting, security, maintenance, and marketing services and technical support activities.

### **GOOGLE ANALYTICS**

To collect standard internet log information and details of visitor behavior patterns. ## **RIGHTS OF THE DATA SUBJECT**

As a user of She is MOM, according to the provisions of the GDPR, you benefit from the following rights:

1. The right of access to information: you can request confirmation that She is MOM who processes personal data regarding your person;

If so, you can request access to the following information:

1. the purposes of the processing;
2. the categories of personal data targeted;
3. the recipients or categories of recipients to whom the personal data have been or are to be disclosed, in particular recipients from third countries or international organizations;
4. where possible, the period for which it is expected that personal data will be stored or if this is not possible, the criteria used to establish this period;
5. the existence of the right to request the rectification or deletion of personal data or the restriction of the processing of personal data relating to the data subject or of the right to oppose the processing
6. the right to lodge a complaint with a supervisory authority;
7. if the personal data are not collected from the data subject, any available information regarding their source;
8. the existence of an automated decision-making process, including the profiling referred to in Article 22 (1) and (4), and at least in these cases, relevant information on the logic used and the importance and expected consequences of such processing data subject.

Suppose the personal data is transferred to a third country or an international organization. In that case, the data subject has the right to be informed about the appropriate guarantees under Article 46 regarding the transfer.

2. The right to rectification: You have the right to obtain, without undue delay, the rectification of inaccurate personal data concerning it. Considering the purposes for which the data were processed, the data subject has the right to obtain the completion of incomplete personal data, including by providing a supplementary statement.

3. The right to delete data ("the right to be forgotten")

You have the right to obtain the deletion of personal data concerning you, without undue delay, if one of the following reasons applies:

1. personal data are no longer required for the purposes for which they were collected or processed;
2. the data subject withdraws his consent based on which the processing takes place, and there is no other legal basis for the processing;



3. the data subject opposes processing according to Article 21 (1)<sup>7</sup>, and no legitimate reasons are prevailing in the processing, or the data subject opposes processing according to Article 21 (2)<sup>8</sup>;
4. personal data have been processed illegally;
5. personal data must be erased to comply with a legal obligation under Union or national law

The exercise of the above rights does not apply to the extent that processing is necessary:

1. for the exercise of the right to free speech and information;
2. for compliance with a legal obligation that provides for processing under Union or national law or the performance of a task performed in the public interest
3. for reasons of public interest in the field of public health,
4. for archiving purposes in the public interest, for scientific or historical research purposes, or statistical purposes, to the extent that the law exercised is likely to make impossible or seriously impair the achievement of the purposes of the processing in question; or
5. for finding, exercising, or defending a right in court.

If She is MOM has released personal data and is obliged to delete it, taking into account the technology available and the cost of implementation, we will take reasonable measures, including technical measures, to inform third parties that process the personal data that the person the data subject requested the deletion by these operators of any links to the respective data or of any copies or reproductions of these personal data.

Art. 21 GDPR Right to object

1. The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her which is based on point (e) or (f) of Article 6(1), including profiling based on those provisions. 2The controller shall no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims.

Art. 21 GDPR Right to object

2. Where personal data are processed for direct marketing purposes, the data subject shall have the right to object at any time to processing of personal data concerning him or her for such marketing, which includes profiling to the extent that it is related to such direct marketing.
